**ARTCC:** In the movie *United 93* (the plane that crashed near Shanksville PA on 9/11), the Boston, New York, Washington, and Cleveland centers were featured. The terrorists failed to reach the White House or the Capitol building in Washington DC because (1) they were delayed for 42 minutes before takeoff, and (2) for some unknown reason, after United 93 got to altitude, they waited a long time to actually hijack the plane. # MINUTES OF THE 2007 NAPP MEETING ARVADA, COLORADO JULY 11, 2007

Total number of members present was 22.

The **ANNUAL MEETING** was called to order at 12:45 p.m. (MDT) in the parish meeting room at Spirit of Christ Catholic Community with President Charlie Teufel presiding. Gene Murray, 1<sup>st</sup> Vice President, opened with a prayer

The **MINUTES OF THE 2006 MEETING** were distributed and reviewed. George Gratton made a motion to accept the minutes as presented and it was seconded by Nick Rossello. The minutes were then unanimously accepted.

The TREASURER'S REPORT was handed out for review. \$604.17 was contributed from the registration fees of 2006 and a number of members provided a sum, above the requested annual membership fee, thus making the financial report a very healthy sum. Thanks to those who contributed more than requested. Checking account has a balance of \$5,097.64 and Savings account has a balance of \$5,512.57. A total of \$10,610.21. Ed Murray made a motion to accept the report as presented and George Gratton seconded the motion. The financial report was then unanimously accepted.

**ANNUAL "GIFT",** amount and recipients, was open for discussion.

(1) Our Colorado hosts, John Capone and Larry Johnston, are very involved in the "Colorado Wing" of the LIFE LINE PILOTS, (providing flights for ambulatory patients and family members at no cost). Gene Murray made a motion to provide \$1,000.00 (in

- the names of John and Larry) to LIFE LINE PILOTS. Ev Hemann seconded the motion and it was approved.
- (2) Jerry Scanlan made a motion to provide \$1,000.00 to Pat Patten and Jacek Rejman, NAPP members, and their FLYING MEDICAL SERVICE in Africa. Ev Hemann seconded and it was approved.
- (3) Because of our extra funds Ev Hemann moved and Jack Paisley seconded that an additional \$1,000.00 donation be offered this year and be given to the Diocese of Fairbanks, Alaska. Motion carried.

FLYING SCHOLARSHIP report was given and consideration for a recipient for this coming year was a matter of discussion. Phil Gibbs completed his IFR training and was awarded the IFR ticket on July 3, 2007, and received the \$500.00 scholarship this year. No one is aware of any individual priest who would like to learn how to fly at the present time. Tim Brown is currently working towards a commercial license and would also like to obtain his CFI rating. Jacek Reiman is giving some thought to obtaining his commercial and multi-engine ratings. Ev Hemann made the motion, and it was seconded by George Gratton, that our president, Charlie Teufel, keep those two individuals in mind when and if he decides to grant the "scholarship(s)". The motion was approved.

NEWSLETTER report was presented by editor, Mel Hemann. He mentioned that over \$1,000.00 was saved in postage, paper and printing this past year because the Newsletter was available to over half the members by electronic means. John Zapp in Grapevine, TX has been a great help in getting the newsletter out. Furthermore, much time and energy is saved on Mel's part when he has fewer envelopes to address, letters to fold and stuff and postage to attach. It was agreed that the "Directory" will continue to be published as hard copy and not go out electronically but be sent by USPS. Mel is in the process of putting all the minutes of previous meetings on CD's along with pictures from past gatherings.

The **NAPP CHARTER RENEWAL** was taken care of by Al Ruschman in the State of Kentucky

with the usual \$4.00 fee donated by Al. Thanks. On July 12, 1964 the NAPP met for the first time in Carrollton, KY. John and Mel Hemann and Phil Schmitt were present then (and now).

MEMBERSHIP HEALTH and DEATHS were reported. As the membership ages it is natural that health issues are more present. The following individual members names were mentioned as having some physical ills: Bill Browne (associate member), Ed Elliott, John Friederick, Ed Higgins and John Walsh (regular members). It was mentioned that Tom Geelan is retiring this month. We remember in our prayers the "souls" of Antoine Attea, Dave Hogan, John Lysogorski and Vincent Merfeld who have entered eternal life this past year. Nick Rossello brought expressions of thanks and gratitude from the Attea family. He also gave a "tribute" in memory of Tony and the long friendship he had with him and shared how Tony had a great love of the NAPP and a BIG HEART in reaching out to many people, especially the poor, in his parishes and the community in which he lived.

REGIONAL REPORTS were accepted. East Region did not have a meeting. Midwest Region report was given by John Hemann. Bill Menzel and John Swing, (regular members) along with Tom Enwright (associate member) hosted the fall meeting in Wisconsin Rapids, WI on September 18, 2006. Fourteen members were present and received a presentation from LTC Brandon Smith about Military Airspace in Wisconsin, especially Volk Field and Fort McCov. The group then had a tour of the Storaenso Paper Mill. On April 30, 2007, Mel Hemann (charter member) and Jim Secora (associate member) hosted the spring meeting in Waterloo, IA. Seventeen members gathered for a noon lunch and then had a tour of the John Deere Tractor Works (largest tractor factory building in the world). Ed Murray will host the group on October 8, 2007, in Spencer, IA for their fall meeting. No report from the West Region.

**2007 CONVENTION REPORT** was given by Gene Murray. He mentioned the positive and "negative" experiences of putting together the annual gathering while living "miles" away from the site. He expressed his gratitude to John Capone and Larry Johnston, his friends in Colorado, who did a great job in actually getting the two day agenda put together. The registration fee was a rather small amount because of the generosity of some "friends" living in the

Broomfield area. For example, the Arvada Associated Modelers (AAM) club members donated their time and remote controlled airplanes to provide all members the opportunity to fly the RC's and then enjoy a complimentary noon lunch at the field. On Tuesday evening the members went to the Boulder Dinner Theater and enjoyed a complimentary dinner and live presentation of "The Sound of Music" provided by an anonymous donor. On Wednesday the use of the meeting room following Mass at the Spirit of Christ Catholic Community provided space and time for the annual meeting and a complimentary lunch. The annual evening banquet, to be held at Three Sons Italian Restaurant, will be a gift from anonymous donors. Gene also announced that associate member, Jack Boyle, will be providing the funds to cover the expenses of the "hospitality room." President Charlie Teufel and 1st Vice President Gene Murray will see that appropriate messages of THANKS are provided to the donors. THANK YOU VERY MUCH.

2008 CONVENTION was the next item on the meeting agenda. George Gratton, associate member, from Savannah, Georgia made a plea for hosting the gathering on July 8 and 9, 2008 in Savannah, GA. He, and several other members on his committee, had prepared some facts concerning motels, agenda happenings and events of interest, and were willing to accept any input from the membership. Mel Hemann moved that we accept his invitation, Jerry Scanlan seconded the motion, and the membership unanimously approved.

Ed Murray was re-elected. Secretary Phil Gibbs was nominated to serve another term by Jack Paisley, seconded by Ev Hemann, and no further nominations were presented. Phil Gibbs was re-elected.

**ADJOURNMENT"** of the meeting took place in the "usual fashion", i.e. Phil Schmitt made the motion to adjourn and the membership approved. Secretary "pro-tem", John W. Hemann
