

MINUTES OF THE 2004 NAPP MEETING

Urbana, Illinois

MINUTES: The Minutes of our 2003 Ames, Iowa Convention had been previously provided in our Newsletter by Editor, Fr. Mel Hemann. In addition Editor Mel provided copies again for distribution at our business meeting. President Ev allowed five minutes for study of the minutes. TREASURER'S REPORT: A written report was distributed by Treasurer, Fr. Mel Hemann. The summary as of July 3, 2004:

COMMENDATION: To Fr. Mel Hemann for 38 yrs of commitment, including new Newsletter in color and the "intriguingly fascinating" 2004 Directory and service as Treasurer followed by resounding, well-deserved applause!

<u>DONATION:</u> Fr. Jack Paisley proposed that \$1,000.00, the most affordable this year, be donated to the Tanzania Flying Medical Service of our members: Fr. Pat Patten and Fr. Jacek Reman. <u>Motion:</u> To accept proposal: Kiernan/Kieffer: passed unanimously.

Gibbs had just recently completed 16 hours of instruction by Fr. Ev in a Cessna 150. Phil is this year's recipient of our \$500.00 scholarship
