### NATIONAL ASSOCIATION OF PRIEST PILOTS INC.

The 22nd Annual Meeting of the National Association of Priest Pilots was called to order by President John Dompka at 9:02 PM on July 10, 1985 at the Plantation Inn Restaurant, Lafayette, Louisianna. The meeting began with prayer. Other Officers present were: First Vice President Bill Bevinton, Second Vice President John Bellon, Treasurer Charlie Teufel, Secretary Jack Paisley, Newseditor Mel Hemann, and Central Region representative John Hemann.

Minutes of the 1984 meeting, which had been printed in the August, 1984 Newsletter, were distributed and read silenting. After comments on a typographical error, a motion to accept the Minutes as printed was made by John Wolesky and seconded by Jim Kelley. Voice vote approval.

Treasurer's report was distributed second copy). Dues paid thus far in 1985 is \$1,370.00 (This does not include Pite Sweeney!) This is an increase and partially the result of the threat to eliminate people from the mailing list if they did not pay their dues. (See comment by new member Michael Nash on page 3 of the June, 1985 Newsletter as the "best deal going.") Charles mentioned that our interest on funds invested and dues enabled us to give \$1,000 people to Father Marc Tillia last year. Other items on the report were self-explanatory. Note to accept the report as printed by Dick Funke and seconded by Jim Kelley. Voice ote approval.

Reports by Mel Hemann: The NAPP hats are almost ... Motion by John Hemann and seconded by Ed Murray that Mel be authorized to order more hats (perhaps 50). Voice vote approval. Mel commented on the special NAPP by the wre which is somewhat out of date and supplies minimal. The Executive Committee divided and recommended ideas for a similar brochure which could be given to prospect the members. Changes might include sites of past and future Conventions, a place for including an address to write for information. An annonymous comment from the flow about a need of changing the out-dated picture of Bob Kirsch. Motion to authorize Mel to have a new brochure printed was made by Al Sigur (our host) and seconded by Art Kirve. Voice vote approval.

The Secretary, Jack Paisley, distributed a proposed change in the By-Laws which would allow the Secretary to keep record of membership in conjunction with the Editor of the Newsletter. Motion by Bob Kirsch and Jim Kelley. The discussion which followed indicated that there was no need for the change. The Secretary acknowledged that he would continue to work with the Editor without any special change. Motion defeated.

The meeting was interrupted with an announcement by the Treasurer that at 9:21 PM this night, the delinquent member, Pete Sweeney, personally handed him Ten U.S. Pollars (\$10.00) for his 1985 dues. A cheer.

Publicity for NAPP was discussed. A number of new members said they were aware of the existence of NAPP but did not know how to contact us. Alongwith the new brochure with a place for an address, the Secretary was told to put our Convention dates on calendars of the following magazines:

Henry Haacke announced that he has paid our Incorporation fee for another year.

Convention sites were proposed: Bob Kirsch, in conjunction with four Bishops, offered to make arrangements for July 8-9, 1986 at Las Cruces, Holy Ghost Retreat House near El Paso, NM. Ideas include a day of flight, perhaps to Carlsbad Caverns. Bob's offer was accepted. For 1987, President John Dompka invited us to Pittsburg where he would offer activities such as the facilities of U.S.AIR, golf, restaurants, etc. Tentative plans are to accept the offer. For 1988, our 25th year, the consensus was to return to Kentucky were Henry Haacke could take us to our "roots".

Our annual contribution of funds to aid flight in the missions recalled the following histroy: we began these contributions in 1978 with a gift to Bishop Arkfeld, this was repeated in 1979 and 1980. Then in 1981 it was the St. James Society, 1982 to Archbishop Hurley, 1983 to Wings of Hope, and last year to Fr. Marc Tillia for Brazil. Suggestions this year were to Bishop Jose Llaguno, S.J.; Fr. Pat Healy in the Bahamas; Bishop of Fairbanks; and to Mike Nash in Juneau, AK. Following good discussion a motion by John Hemann and John Wolesky to send our contribution this year to Bishop Jose Llaguno, S.J. who will be one of our hosts for the 1986 Convention. Voice vote approval.

THANKS were expressed to our host, Fr. Al Sigur, and his capable assistants, especially Jim Landry. A generous applause.

Elections this year: President, Second Vice President and Secretary. Present officers are eligible for re-election. Nominations for President accepted. John Dompka was nominated by Bob Kirsch and Henry Haacke. Motion by Bob Kirsch and John Wolesky to close nominations and cast an unanimous ballot for John Dompka. Voice vote approval. Nominations for Second Vice President accepted. Henry Haacke was nominated by Phil Schmitt. After some discussion, John Bellon was nominated by Al Sigur. Motion to close nominations by Bob Kirsch and Art Kleve. Voice vote approval. Paper distributed for ballots. John Bellon was elected for a second term. Nominations for Secretary accepted. Bob Kirsch nominated Jack Paisley. Peter Sweeney and Frank Nemmers were nominated but withdrew. Motion to close nominations and an unanimous ballot for Jack Paisley. Voice vote approval. (Elections in 1986: First Vice President and Treasurer.)

Announcements: President Dompka encouraged all to mark their calendar for July 8-9, 1986 for our Convention in New Mexico. Mel Hemann encouraged members to notify him of change of address because of higher postage rates for returned mail. Pictures for Directory are best if black and white. Plans for departure van to airport on Thursday morning through Jim Landry at 7, 8 and 9 AM. Video of Channel 3 news story shown by John Friederick. Copies can be purchased through him.

Motion for ajournment at 10:06 PM by John Hemann and Frank Nemmers. Voice vote approval.

Following her delightful presentation we celebrated the Liturgy and then toured the grounds.


After viewing all of the above the bus took us to the airport where we participated in the seminars at the Paul Fournet hangar.

Tennis, shuffleboard, swimming or just plain loafing was there for the asking.


The highlight of the evening was a tour of Ashy's beautiful home and then the crawfish boil.
